他在出席太平后廊华人公会庆祝 19 周年晚宴时说,该部在国内拥有 32 所各种技职培训中心,供成绩中等的学生申请,当局也降低申请资格,包括在大马教育文凭考试的国文和历史科目不及格、只要届满 17 岁或以上,即可通过该部队技能倾向测试获得及格后,即可录取就读第一至第三级的国家技术课程。

他强调,该部也希望这项培训课程,能获得华团的配合支持,共同推介该部的技职课程,并鼓励更多华裔生入读,一旦被录取入读,除获免费学费及住宿外,也提供生活津贴等。

他认为,通过这项课程,有助于解决我国严重短缺技职人才的问题,进而无需再依赖外劳,并说,海外国家包括韩国、德国、日本甚至新加坡等国家,早已向技术教育迈进,也让该国的工业蓬勃。

他也代表部长古拉宣布拨款 5000 令吉予该会。

Socso protection for rubber smallholders, farmers, fishermen

MACHANG: The human resource ministry plans to extend the personal and family protection scheme through the Social Security Organisation (Socso) contributions to farmers, rubber smallholders and fishermen.

Its deputy minister, Datuk Mahfuz Omar, said currently, only certain groups had the opportunity to contribute to the scheme, including making it compulsory for taxi, Grab and bus drivers, effective this July.

"This is because this group is at high risk of getting involved in accidents while at work," he told reporters after presenting aid to Mohd Nor Daud, 64, whose son Mohamad Izzuddin, 31, had drowned at the Kemubu pump house, here, on June 11.

Mahfuz said the ministry wanted the groups concerned, including their families, to get the same benefits in the event of an accident, especially involving the loss of lives.

He said that contributors could choose an appropriate amount, from RM13 to RM452 monthly, based on their income level.

The amounts are not a burden compared to the benefits they could receive, including lifelong fixed monthly aid, he said.

Mohd Nor Daud said he did not expect to receive RM332 monthly following his son's death.

He said Mohamad Izzuddin, a lorry driver, was the fourth child among six siblings, and was due to get married in November.
